Know all men by these presents

that I William D Goodwin of  
Greenville County, in the state aforesaid in consideration of one  
thousand Dollars to me paid by Thomas W Davis of Greenville  
County in the state aforesaid have granted bargained sold and  
released and by these presents do grant bargain sell and release  
unto the said Thomas W Davis all that certain piece parcel and lot  
of land situate lying and being in the said County and State on  
the west side of Main Street in the City of Greenville, being a part  
of the north side of the lot of the said Goodwin, and adjoining the lot  
of the said Davis and having the following boundaries and dimensions  
to wit: Four and one half (4 1/2) feet front on Main Street and  
running thence from the terminal points of said front - west from  
Main Street, on the north side with said Davis lies two hundred and  
thirty eight (238) feet (more or less) to Laurens Street, and on the south  
side, or a parallel line west from Main Street one hundred and  
forty eight feet (148) to a tree, thence in a line parallel with  
Main Street ninety (90) feet four feet to a stake, thence in a line  
parallel with said Davis line, and running West from Main  
Street Ninety (90) feet more or less to Laurens Street said street hav-  
ing a front of six inches (6) on Laurens St. and running towards  
Main St. the same width - say 90 ft; & from said last mentioned  
point to Main St (148 ft) being four and a half feet wide - inclu-  
ding 6 inches in which the foundation of the North walls  
of the Slave and Wash houses of the said Goodwin stands and  
a half interest of in said North walls, their entire length  
Together with all and singular the rights, members hered-  
itaments and appurtenances to the said premises belonging, in  
any wise incident or appertaining. To have and to hold the  
and singular the premises before mentioned, unto the said  
Thomas W Davis his heirs and assigns forever. And I do  
hereby bind me my heirs executors and administrators, to wa-  
ant and forever defend all and singular the said premises  
unto the said Thomas W Davis his heirs and assigns  
against me and my heirs, and every other person whomsoever  
lawfully claiming, or to claim the same, or any part thereof.
