and ninety six Dollars to me paid by John T. Robertson  
of Greenville County and State aforesaid, have granted bar-  
gained sold and released, and by these presents do grant bar-  
gain sell and release unto the said John T. Robertson all  
that piece parcel and tract of land situate in the County  
of Greenville, and the State aforesaid lying East of the Cum-  
ber Road, and being a part of the tract purchased by  
said Aaron Griffith of George Seaborn of Anderson  
County and State aforesaid, containing Sixty six and a  
half Acres more or less, and having the following metes and  
bounds, to wit: Beginning at a white oak s<sup>r</sup> on the road lead-  
ing to Wm C Carles Mill thence along Carles line S 4 1/2  
E 10.15 chs to a stake s<sup>r</sup> on, thence S 59 3/4 W 9.67 chs to a  
stake n m; thence S 44 1/2 E 33.11 chs to a stake s<sup>r</sup> thence N 61 E  
17.08 chs to a station s<sup>r</sup> on, thence N 38 3/4 W 32.90 chs to a  
stake s<sup>r</sup> on thence N 83 1/2 W 15.00 chs to white oak the begin-  
ning

lawfully claiming or to claim the same or any part thereof
