


of Reedy River being bounded and defined as follows beginning at Pine 3x running N 88 W 31.75 to maple 3x thence N 23 1/2 E 17.75 to Black Oak 3x at Wilson's bridge road, thence along said road 13.50 to a stake 3x thence S 10 E 7 to Red Oak 3x thence S 68 1/2 E 7.50 to stake 3x thence S 7 E 13.50 to the beginning corner containing forty nine and one quarter acres more or less being some tract of land conveyed to me by Thos L Harrison by deed dated 11<sup>th</sup> day of February A.D. 1852, also all that other piece parcel of tract of land lying and being in County and State aforesaid on the head waters of Rabrus creek waters of Reedy River containing two hundred and thirty eight acres more or less beginning on a stone 3x on Wilson's bridge road thence road line to a Spanish oak 3x thence S 23 1/2 W 17.20 to a maple 3x on branch thence S 87 E 30.70 to pine stump 3x thence S 6 W 38.40 to chestnut down 3x stone 3x thence N 86 1/4 W 56.70 to a Spanish oak 3x thence S 11 1/4 W 31.50 to the beginning corner bounded by lands of Mrs Francis West Jonathan Gary Wm Howard Mrs Mc Templeton and others as described in a deed of the same time from John B Hammond and wife bearing date the 26<sup>th</sup> March A.D. 1875, also all that piece parcel or tract of land situate lying and being in the County and State aforesaid containing seven acres more or less and which is described in a plat of the same attached to a deed of the same from L M Harrison and M J Harrison to H and Chesterfield Gary and Jonathan Gary bearing date the 5<sup>th</sup> day of April A.D. 1864.

Together with all and singular the appurtenances hereditaments thereto belonging or in any wise incident or appertaining and the reversions, remainders or remainders, rents issues and profits thereof and all the estate right and title interest and property claims and demand whatsoever of me the said Jonathan Gary of us and to the aforesaid tracts of land with the appurtenances and every part thereof.
