Stokes of Greenville County, in the State aforesaid, in consideration
of One thousand and forty-eight Dollars to us paid by A W Holl-
iday of Greenville County, in the State aforesaid, have granted bur-
gaged sold and released and by these presents do grant burgage
sell and release, unto the said A W Holliday, all that tract or par-
cel of land containing One hundred and thirty one Acres (be the
same more or less) situate in State and County aforesaid lying on
and near Saluda River it being a part of the Bolling & Morris
Tracts of land, Beginning on a Stone 5x on Saluda River thence N
80° 65' 25" to a stone 3x thence N 83 1/4 E 17.10 to a Pine 3x dead tree
N 38, E 11.00 to the Road and stone 3x thence N 27 W 21.50 the road
the line to a stone 3x thence S 65 E 75.00 to a stone 3x thence S 14
W 8.00 to the beginning corner bounded by lands belonging to
James Holliday all other sides by lands Mrs A M Stokes
Together with all and singular the rights members hereditaments and
appurtenances to the said premises belonging, or in any wise inci-
pient or appertaining, To have and to hold all and singular the
premises before mentioned, unto the said A W Holliday his
heirs and assigns forever, And we do hereby bind ourselves
our heirs executors and administrators, to warrant and forever
defend all and singular the said premises, unto the said A W
Holliday his heirs and assigns, against the aforesaid Stokes and
them heirs and every other person whomsoever lawfully
claiming, or to claim the same or any part thereof,

the year of our Lord One thousand eight hundred and
seventy seven and in the one hundred and second year of the
independence of the United States of America
