Know all men by these presents that I Robt A Bates of Spartanburg County in State aforesaid for and in consideration of Eight hundred Dollars to me paid by H. N. Fisher of Greenville County in State aforesaid have given granted bargained sold and released by these presents do give grant bargain sell and release unto the said H. N. Fisher all that tract of land which formerly belonged to Hosea H. Woodford lying and being in Greenville County on both sides of Mill Creek waters of South Pacolet river. Beginning on a pine on the Greenville line & running thence N 37 1/4 W 31.50 chains to Black Oak near the fence. thence along fence N 24 3/4 E 14.25 chains to stake; thence along said fence N 4 1/2 W 12 chains to stake in fork of branch; thence up meanderings of said branch about 10.50 chains to Large Poplar thence N 14 3/4 W 29.25 to Post Oak; thence along the line dividing original tract South 58 3/4 E crossing Mill Creek 43.40 chains to Black Oak; thence N 6 1/4 W 30.20 chains to pine knob; thence N 6 1/4 W 15.25 chains to stone on blank mountain Parton's corner; thence S 8 3/4 E 17.75 chains to stake near head of Tarkill branch. thence S 10 W 10 chains to stake near Moss old house place; thence S 37 1/4 W 13.75 chains to pine stump on little road; thence S 1 W 8 chains to dead Black Jack; thence S 65 3/4 E 17 chains to pine Alex Pmetts corner thence N 17 1/4 E 19.25 chains to stake not found; thence S 70 E 2.75 chains to pine Alex Pmetts corner; thence S 8 3/4 E 60 chains to Post Oak. thence S 10 E 8.90 chains to dead chestnut at Hughes dalls draw far 2; thence N 73 1/2 E 14.75 chains to dead chestnut; thence S 88 E 26.50 chains to some Campbells corner, N 32 E crossing Mill Creek 30 chains to the beginning pine corner, containing four hundred & seven acres, be the same more or less Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise appertaining, To have & to hold all & singular the premises before mentioned unto the said Henry N Fisher his heirs and assigns forever, and I do hereby bind myself my heirs executors & administrators to warrant and forever defend all and singular the above described premises unto the said Henry N Fisher his heirs & assigns against me & my heirs & against every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof, except about forty three acres of North West part of said tract of land, which one & my heirs do hereby release all claim forever.
