 in the State aforesaid (the receipt whereof is hereby acknowledged)
 have granted bargained sold and released, and by these presents
 do grant bargain sell and release unto the said John Har-
 rison Jr all that tract or parcel of land situate lying and being in
 the County of Greenville and State aforesaid, on the East side
 of Reedy River, beginning at the mouth of Lemple Creek
 thence up the same as it now runs until it intersects an
 old line at or near a Red Oak on West side of said creek
 thence on said line N 24 E to a Rock formerly a Red oak
 near Richardsons fence, thence N 6 W to Lewis Huffs corner
 thence N 70 W to Reedy River thence down the middle of the
 River to the beginning containing Three hundred acres be the
 same more or less, also a small parcel of land at our mill dam
 containing one and a half acres including half of
 River, being the land purchased of Maria L. Harrison
 Together with all and singular the rights, members, hereditaments,
 and appurtenances to the said premises belonging, or in anywise
