Know all men by these presents that we R M Cleveland and Ferrimiah Cleveland by J H Cleveland our witness and attorney Mrs Eliza Poole Mary H Cleveland widow of B H Cleveland Mary M Cleveland daughter of B H Cleveland and deed Jesse H Cleveland and Ferrimiah Cleveland J H Cleveland Wm Choice and Caroline his wife heirs at law of Ferrimiah Cleveland deed of Tean, Geo and Soa in consideration of Four hundred and fifty Dollars to us paid by Edmund Hooker of Greenville in the State aforesaid, have granted bargained sold released and by these presents do grant bargain sell and release unto the said Edmund Hooker all that plantation and tract of land lying and being in the District of Greenville and State aforesaid containing two hundred acres more or less it being all the land owned by Benjamin Bridges adjoining said tract at his death which will more fully appear by reference to the deed from Joseph Bridges to Benjamin Bridges, Thomas Edwards and others to Benjamin Bridges and conveyed by James Bridges and Edmund Bridges to Ferrimiah Cleveland deed by deed dated the second day of November one thousand eight hundred and thirty three as will be seen by reference to said deed as also to the deed from Joseph Bridges to Bridges and the deed from Thomas Edwards to Benjamin Bridges all of which are hereto attached the land hereby conveyed lies South of Paris Mountain joining on the East lands of Wm Choice and Absolun Neely and bounded North by lands claimed by Blackdy Thompson or Paris Mountain Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining, To have and to hold all and singular the premises before mentioned unto the said Edmund Hooker his heirs and assigns forever, and we do hereby bind ourselves our heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Edmund Hooker his heirs and assigns against us and our heirs and every other person whomsoever lawfully claiming, or to claim the same or any part thereof
