To all to whom these presents shall come. - I Perry D Gilreath Sheriff of Greenville County and State

of aforesaid send greeting: Whereas, by virtue of a writ of Fieri Facias issued out of the Court of Common Pleas, held for the County of Greenville, dated the eighteenth day of February in the year of our Lord one thousand eight hundred and sixty seven, at the suit of Robert McKay Executor, directed to all and singular the Sheriffs of the State aforesaid, commanding them, that of the goods and chattels, houses, lands, hereditaments and real estate of Dorcas Green to levy the sum of One thousand one hundred and eight 9/100 Dollars, damages

and costs, A. D. D. Nickers, Sheriff as aforesaid, as will appear on his sale Book page seventy six, have granted, bargained and sold and by these presents do grant bargain and sell unto the said Ann E Marshall her heirs and assigns forever, the said piece parcel and tract of land with its appurtenances, and all the estate, right, title and interest which the said Dorcas Green of right had of, in and to the same; To have and to hold the said piece parcel and tract of land, with its appurtenances unto the said Ann E Marshall her heirs and assigns forever as fully and absolutely, as if the said Perry D Gilreath might, could or ought to grant bargain and sell the same, by virtue of the Statute aforesaid and the said writ of Fieri Facias, or other wise.
