aforesaid, for and in consideration of the sum of Three thousand Dollars
to me in hand paid at and before the sealing of these presents, by J.W.
Eagle of Greenville County in the State aforesaid (the receipt whereof
is hereby acknowledged) have granted bargained sold and released,
and by these presents do grant, bargain sell and release unto the
said J.W. Eagle his heirs and assigns all that certain piece or lot of
land situate lying and being in the City of Greenville in the State
and County aforesaid on Main and Avenue Streets and known as the
McBee Hall Lot and hath the following metes and bounds to wit:
beginning at an iron pin corner of Main and Avenue Streets and
runs thence with Main Street 17 1/2 E twenty four feet to a stake

thence N 7 1/2 W. Twenty five feet to a stake, thence S 18 W. twenty four
feet to a stake on Avenue street thence with said street S 7 1/2 E. Seventy five
feet to the beginning corner on Avenue and Main streets and containing
