paid at and before the sealing of these presents by Mary Wim of
Greenville County in the State aforesaid (the receipt whereof is hereby
acknowledged) have granted bargained sold and released and by these presents
do grant bargain sell and release unto the said Mary Wim all that House
and lot situate lying and being in the City and County of Greenville and
State aforesaid on Brunswick Street bounded by lots of Whitman &
Symmes Estate of W F McBee, the said Mary Wim and containing two
Acres and one half more or less and all orw as a part of the Early
Rowland lot. Together with all and singular the rights members
hereditaments and appurtenances to the said premises belonging, or in anywise
incident or appertaining, to have and to hold, all and singular the said
premises before mentioned unto the said Mary Wim her heirs and assigns
forever. And I do hereby bind myself my heirs executors and administrators
to warrant and forever defend all and singular the said premises
unto the said Mary Wim her heirs and assigns, against me and my heirs
& every other person lawfully claiming or to claim the same or any part
thereof.

and recorded in record of probate

I B J Douthit Judge of Probate for the County of Greenville
greeting: whereas M A Balson on or about the 5th day of October 1878 did
exhibit his Petition in the Court of Probate at Greenville Circuit House
in the County of Greenville and State aforesaid against E A Phillips and
A A Henderson. And the cause being at issue before the Honorable Court
aforesaid came on to be heard on 20th day of November 1878 when the
said Court after full hearing thereof and mature deliberation in the
premises did order adjudge and decree, that the tract of land, belonging
to the Estate of O P Phillips deceased, hereinafter mentioned and described
should be vested in M A Balson at the sum of Five hundred and
forty eight Dollars. the appraised value of the same. Now I know
all men that I the said B J Douthit Judge of Probate as aforesaid, in
consideration of the premises and also in consideration of the sum of
five dollars, paid me by the said M A Balson, the receipt whereof is
hereby acknowledged, have granted bargained sold and released and by
these presents do grant bargain sell and release unto the said M A
Balson and his heirs and assigns all that tract of land situate lying
and being in the County of Greenville and State aforesaid bounded by
lands of Choice and others, beginning at a Black Linn 0 x 0 thence N
3 E 28.00 to a stone 8 x n, thence 87 1/4 W 48.07 to a stone 3 x n, thence
81 1/4 E 33.00 to a Stake in road, thence 8 5/8 E 5.98 to a stone 3 x n, thence
N 34 1/4 E 9.70 to a Stake in branch of fork, thence N 34 1/4 E 10.40 with
meanders of branch to a Stake in branch, thence 8 87 1/4 E 17.88 to the beginning
corner, and containing One hundred and eighteen and a fourth acres more or
less. Together with all and singular the rights members hereditaments and
appurtenances whatever, to the said premises belonging, or in anywise
appertaining, and the reversions and remainders rents issues and profits
thereof. And also all the estate, right, title interest owner possession
property benefit claim and demand whatever, both at law and in
Equity of the said M A Balson and of all the parties to the said
suit, and of all other persons rightfully claiming, or to claim the
same, or any part thereof, by, from, or under them or either of them.
To have and to hold the said tract of land with its hereditaments privi-
leges and appurtenances, unto the said M A Balson his heirs and as-
signs forever.
