anywise concern. I, S. J. Douthitt Master of the County of Greenville in the State aforesaid, send greeting: Whereas a petition was filed in the Probate Court for said State and County, on the 16th day of August 1878, by Flora A. Buis against J. A. Buis, H. B. Buis, E. B. Anderson, May S. Rivingo, J. H. Lelyde, E. Summers Buis, Flora L. Buis and George A. Buis, to partition the Real Estate of E. J. Buis deceased, and whereas the said real estate was sold under said proceedings on Saturday in November AD 1878 and whereas it has since been decided by the Supreme Court that the Probate Court was without jurisdiction in such cases, and whereas it became necessary to institute proceedings in the Court of Common Pleas for the State and County aforesaid to confirm the said Partition, and whereas a complaint was filed in the said Court of Common Pleas on the 18th day of April AD 1879 and upon the hearing of said cause the said Court amongst other things did order, adjudge and decree
