State aforesaid, in consideration of the sum of Sixteen hundred and fifty Dollars to one in hand paid at and before the sealing of these presents, by James Alvin Cannon of Greenville County in the State aforesaid, (the receipt whereof is hereby acknowledged) have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said James Alvin Cannon - One half interest in the following tract of land, to wit: all that tract of land situate lying and being in the State and County aforesaid, adjoining lands of John Gault, Thomas Goldsmith, Mr Mr Jones, C. D. Garrett, and J. R. Riddle and others, and containing Two hundred and ninety five Acres more or less, being Three separate tracts of land purchased by me of W. Bowman and W. Bowman & Co together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, To have and to hold, all and singular the said premises before mentioned unto the said James Alvin Cannon his heirs and assigns forever, And I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said James Alvin Cannon his heirs and assigns, against me and my heirs, and every other person lawfully claiming, or to claim the same, or any part thereof.
