in the County and State aforesaid on branch waters of Gap creek waters of North fork of Saluda River containing fifty Acres more or less Beginning on a chestnut on the side of the Hill below the Hickman field running nearly North to a Hickory near a large pile of Rocks west of Jacob Pruitts Jr thence with the old line nearly west to a chestnut west of the David Roak Spring thence nearly South up the ridge to a chestnut at the fence thence with the old line up the fence and to Partman Howards Roak corner thence nearly South East to the beginning chestnut corner, Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining To have and to hold all and singular the premises before mentioned unto the said Jacob Pruitt his heirs and assigns forever, and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Jacob Pruitt his heirs and assigns against myself my heirs and every other person or persons, whomsoever lawfully claiming or to claim the same or any thereof.
