to me paid by S J Donthick in the State aforesaid, have  
granted bargained, sold, and released, and by these presents  
do grant bargain sell and release unto the said  
S J Donthick all that tract of land situate lying and  
being in the City and County of Greenville in the  
State aforesaid adjoining lands of Adam Walker  
Charles T Hoamubds and others and containing  
Fourteen acres more or less being the land origin-  
ally conveyed to me by A L Cobb Together with  
all and singular the rights member hereditaments and  
appurtenances to the said premises belonging or in  
any wise incident or appertaining, To have and to hold  
all and singular the premises before mentioned unto the  
said S J Donthick his heirs and assigns forever, and I  
do hereby bind myself my heirs executors and adm-  
inistrators to warrant and forever defend all and  
singular the said premises unto the said S J Don-  
thick his heirs and assigns against me and my  
heirs and every other person whosoever law-  
fully claiming, or to claim the same or any part  
thereof.

State of South Carolina  
County of Greenville  
Contract Entered into  
between Robert E Chapman  
an on the one part and Luke Chapman on the other  
part witnesseth that R E Chapman of the first  
part has bargained and sold a tract of land known  
as a part of the Purson tract to Luke Chapman of  
the second part for the sum of One thousand Dollars  
said tract of land containing 156 Acres more or less  
the said Luke Chapman is to pay five hundred  
Dollars by the first day November 1880 at seven  
per cent interest from date and the remaining  
five hundred Dollars by the first day of November  
1881 with interest from date in default of first  
payment the said Luke Chapman is to give to  
the said R E Chapman eight Bales of middling cotton  
to weigh 4.25 each as a Rental for said tract of land  
described above the said Luke Chapman further  
agrees to deliver to R E Chapman in default of  
payment of the five hundred Dollars the eight  
Bales of cotton by the first day November 1880  
at the Gin House of Luke Chapman
