in the State aforesaid, in consideration of the sum of Seven hundred and forty five Dollars to me paid by *Lewis Blythe* of Greenville County in the State of ~~South~~ Carolina have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said *Lewis Blythe* (all that certain piece parcel or tract of land situate in the County and State of ~~South~~ Carolina on both sides of the Atlanta and Richmond Air Line R.R. and also on both sides of the road leading from Greenville to the Chickasaw Springs to Sparta and having the following metes and bounds viz. Beginning on a stone corner at *Greenwood* corner *Greenwood* & *W. M. Chase* line to the center of said R.R.

line N 75 W 39 70 ch crossing the wagon R<sup>d</sup> to Chick Springs & the Jackson Grove R<sup>d</sup> to a small black gum on the side of sd R<sup>d</sup> *Greenwood* *Westfield's* corner thence S 21 1/2 E with *Westfield's* line 16 75 ch to a stone at corner of *Landsfield's* & also *Westfield's* corner thence South 72 3/4 E 16 88 ch with *Landsfield's* line crossing the said *Chick Springs Wagon R<sup>d</sup>* to a stake in the center of the said R<sup>d</sup> thence with the center of sd R<sup>d</sup> South 55 1/2 West 10 45 to a stake in center of sd R<sup>d</sup> thence S 82 1/4 E 36 94 ch with *Croft's* line to the beginning stone corner containing by survey of *W. D. And I do hereby bind my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said *Lewis Blythe* his heirs and assigns against myself and my heirs and every other person whomsoever lawfully claiming or to claim the same or any part thereof.
