and have granted, bargained, sold, alien, released, and by
these presents do grant bargain, sell, alien, release unto
the said B. V. Watson all that plantation or tract
of land on the west side of the Factory Row adjoin-
ing Miller Ross and Thomas Steen's land bounded
by four acres and fourth acre beginning on Black
Cats 111+ on Miller Ross line thence N 67 1/2° E 2000 chains
and 71 Links to Rock 111+ on Thomas Steen's line
thence N 33° W 11 chains 50 links up Factory
Row to Rock 111+ on road thence S 87 1/2° W 6 chains
and 20 links to Rock 111+ on Miller Ross line thence
S 55° E 11 chains and 50 links to beginning Black Cats
Together with all and singular the Rights, Tenements,
Appurtenances and appurtenances to the said pre-
