808	John Gosnell to Elizabeth Gosnell	Deed	The State of South Carolina Know all men by these presents that I John Gosnell of Greenville County in the State of aforesaid for and in consideration of the sum of Two Hundred Dollars to me in hand paid at and before the sealing of these presents by Elizabeth Gosnell of Greenville County in the State of aforesaid (the receipt whereof is hereby acknowledged) have granted bargained sold and released and by these presents do grant bargain sell and released unto the said Elizabeth Gosnell a tract piece or parcel of land lying and being situate in Greenville County and State aforesaid on Roanoke waters of North Fork of Saluda River and is part of the Ballaban tract and runs as follows Beginning on a Pine or on Potatoes line near the road leading from Flat Rock (on the Road) to Jake Pruitt thence to a white oak or (conditional line) thence to a Red Oak or near the fence there due north to Jake Pruitt's line of Howard tract thence along Jake Pruitt's corner

lines to a hickory or thence to Locust or on above named road thence with Robert's line to the beginning containing by estimation One hundred and fifty acres more or less bounded by lands of Jacob Pruitt Robert's own and others. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the said premises before mentioned unto the said Elizabeth Gosnell her heirs and assigns forever and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Elizabeth Gosnell her heirs and assigns against me and my heirs and every other person lawfully claiming or to claim the same or any part thereof.
