the said Joshua Lindsey his heirs and assigns forever,
and I hereby bind myself my heirs executors and
administrators to warrant and forever defend
all and singular the said premises unto the
said Joshua Lindsey his heirs and assigns against
myself my heirs and every other person or persons
whomsoever lawfully claiming or to claim the
same or any part thereof.
