Seven Dollars to me paid by Henry W
Carrier of Greenville County in the State
aforesaid, have granted, bargained, sold
bid released, and by these presents do grant
bargain, sell and releases unto the said
Henry W Carrier his heirs and assigns,
all that certain tract or parcel of land
situate lying and being in the County and
State aforesaid just outside of the limits
of the City of Greenville on both sides of
the North fork of Musky Creek front-
ing what is known as the Casley Bridge
Road & partly fronting the Pendleton Road
beginning on one stake corner on Pendleton
Road & ending at the same on the
