in consideration of the sum of Four Hundred thirty two
Dollars to us in hand paid, at and before the sealing
of these presents, by Sarah A. Tripp of Greenville
County in the State aforesaid. (the receipt whereof
is hereby acknowledged) have granted bargain-
ed sold and released, and by these presents
do grant bargain, sell and released, unto the
said Sarah A. Tripp, all that certain lot or par-
cel of land, situate lying and being in Greenville
County and State aforesaid on the N.W. side of
the road leading from P. E. Deane's old
Place to Reedy River Church, and on branch
waters of Reedy River, beginning at a stone in
said road and running thence N 60 W 20.00 to a
stone 3x thence N 42 W 11.55 to a stone 3x, thence
South 11.00 to a Poplar 3x3x, thence S 60 E 25.00 to a stone
in the said road, thence with said road N 34 E 12.00
to the beginning corner, containing thirty six
Acres more or less, marked on plat No. 2, and
being the interest of Sarah A. Tripp and B. F. Moon
in the tract of land formerly owned by W. B.
Moon Dec^d Together with all and singular
the rights, members, hereditaments, and appur-
tenances to the said premises belonging, or in
