have granted, bargained, sold, and released, and by these
presents do grant, bargain, sell, and release unto the
said Robert G Williams, all that certain piece parcel
and lot of land, situate lying and being in the City
of Greenville in the County and State aforesaid, on the
West side of main Street and bearing the following
lines, notes and bounds, to wit, Beginning at the center
of the East end of the wall which divides the store at
present occupied by J.A Goodwin from that occupied by
Robert G Davis on main Street and running thence
with main Street South and

Center of the North Wall, of said last named store on
main Street; thence with a line, through the entire length
of the center of said north wall and with S.W Davis line

tinuing through the center of the north wall of brick
stable, 90 feet and 6 inches, to Lawrence Street; thence with
