 and by these presents do grant bargain sell and
 release unto the said Sarah M. Williams all that
 piece parcel or lot of lands situate lying and being
 in the City of Greenville State of South Carolina
 Beginning at a State corner on Pendleton Street and a
 Cross Street sixty feet wide and commencing thence S
 16 1/4 N. Four hundred feet to a State corner Cross
 Street thence S 73 3/4 E. Two hundred and one half
 feet to a State thence N. 16 1/4 E. Four hundred feet
 to a State on said Pendleton Street thence N 73 1/4 W.
 Two hundred and one half feet to Beginning Corner
 Containing one acre and 24/100 and marked lot no 1 on
 plat
 Together with all and singular the Right members
 Appurtenances and Appurtenances to the said premises
 belonging or in anywise incident or appertaining
