Hillis line S 40° 2' 00" E 28.16 to a stone thence North with John Cornells line 47° 2' 00" E 33.6 to a corner 3x thence S 70° 10' 00" W to a stone (pine cut down) thence N 62° 00" E 18.4 to the beginning corner, containing thirty one acres more or less it being a tract of land conveyed to me by Robert Pittman together with all and singular the rights, numbers, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the said premises before mentioned unto the said Andrew W.
