 whereas George Greet late of Greenville
 County and State aforesaid, departed this life, intestate
 and unindebted, in the year 1868, seized and possessed
 of two tracts of land, one containing 101 Acres
 and the other 96 Acres, in all 197 Acres, which have since
 remained in the possession of his widow, Delila Greet,
 and whereas the said George Greet (decd.) left surviving
 him as his heirs at law and distributees his widow
 Delila Greet and eight children, to-wit: Daniel M. Greet,
 James Greet, Cornelia Bridwell, Mary Priestly, S. M. Greet,
 W. H. Greet, J. M. Greet and Pauline Pickens, all of whom
 are above the age of twenty-one years, and whereas no
 partition or division of said Real Estate has ever been

 further consideration of the sum of five dollars to us
 paid by the said S. M. Greet, the receipt whereof is hereby
 acknowledged, have granted, bargained, sold and released
 and by these presents do grant, bargain, sell and release
 unto the said S. M. Greet all our Right, Title and interest
 in and to a certain Lot or parcel of land belonging to
 the Estate of the said George Greet (decd.) situate in Green-
 ville County and State aforesaid, on the North side of
 of the Rutherford Road and on a small Branch of Goose
 River and known as Lot No. 3 in the J. K. Dickson survey
 made the 2nd day of December 1854, containing fifteen
 Acres, more or less, bounded by a plat hereto attached
 together with all and singular the rights, members, heredi-
 taments and appurtenances hereunto belonging, or
 in anywise incident or appertaining, to have and to
 hold all and singular the premises before mentioned
 unto the said S. M. Greet, his heirs and assigns forever.
 And we do hereby bind ourselves our heirs, executors
 and administrators to warrant and forever defend
