 and Greeting: Whereas, Elisha D. Canada Administrator
 of the estate of James Canada deceased, suing in
 the name of Elisha D. Kennedy as Administrator of the
 estate of James Kennedy deceased, on or about the
 18th day of September in the year of our Lord eighteen
 hundred and eighty three exhibited his complaint
 in the Court of Common Pleas for the County of said

 and Alfred Taylor containing ninety acres more or
 less Together with all and singular the Rights
 Members Hereditaments and Appurtenances to
 the said premises belonging or in anywise inci-
 dent or appertaining and all the estate right title
 claim and interest whatsoever of the parties to
 the cause aforesaid and of each of them in and to
 the same and of all other persons rightfully claim-
 ing from under or by these or any of them To have
 and to hold all and singular the premises before
 mentioned unto the said S. Hahn by heirs and as-
