Johnson (the receipt whereof is hereby acknowledged,) have granted, bargained, sold and released, and by these Presents, DO GRANT, bargain, sell and release unto the said John L. Johnson a certain tract or parcel of land containing one hundred and 50 acres, more or less, lying and being on Water, of Wolf Creek of Middle Saluda River, adjoining lands of Mary A. Mullinax & Jas. Mullinax and others, Beginning on Spanish Road on the Edwanda Lurvey near the road, thence N 74° 0' W with the Edwanda Survey 7 ch. 50 links to Maple 3/4 hewn with the Wolf Creek back to the first Branch, thence with said branch to the Wolf Creek Road, thence down with the road to the Magell Branch, thence N 45° 0' W to the head of Mary Anderson line, thence with said line to the stone corner on the Pinnois Centinel land, thence with said line to Mary A. Mullinax line, thence with said line to the back line, thence with back line to the corner, thence with Pinnois Centinel line to the beginning, except the side line, which is beginning on the Creek, measuring the same across the creek up above Creek to where some stone is, thence 10 yds on each side of said creek down to the clearance land, thence also the clearance land 10 yds on each side of the creek down to the clearing spring, thence with spring boundary to the creek, thence with the creek to the beginning.
