Boling Trustees of School District No. 16 in Saluda Township a certain tract of land lying or part of Land in the County and State aforesaid situated being and lying in Greenville County in the lower portion of Saluda Township on the West side of the old Greenville and Ashville stage road and lying contiguous to said road and runs as follows: Beginning at rock corner on the edge of the said old stage road at a point where J. M. Boling's line and said road intersects and due North two chains and 82 links to a rock corner, thence N 2 90° E 2 90 chains to rock corner thence due South 2 32 chains to rock corner on J. M.
