Munks in the State of South Carolina (the receipt whereof is hereby acknowledged,) have granted, bargained, sold and released, and by these Presents, DO GRANT, bargain, sell and release unto the said David R. Munks all that certain lot or parcel of land situate lying and being in the city of Greenville on the South Side of Choice Avenue and having the following metes and bounds to wit: Beginning on a stake or on the South side of Choice Avenue distant Three Hundred and twenty feet East from the intersection of Prof. C. H. Judson's line with the South side of Choice Avenue and running thence due South one hundred feet to a stake or thence due East Fifty Eight and one half feet to a stake or thence due North one hundred feet to a stake or on Choice Avenue thence due West Fifty Eight and one half feet to the beginning corner and bounded on the West by lands formerly belonging to J. B. Williams and on the South and East by lands of J. D. Harris and on the North by said Choice Avenue.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.

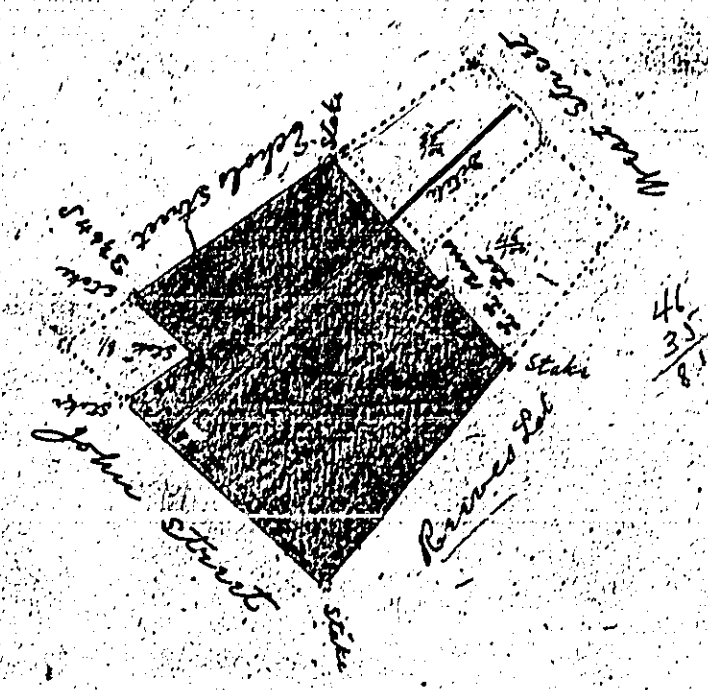
