P. Johnson D. D. on September 6th 1882 beginning at a tree in main branch D 5 2 1/2 E 20.00 to Stake & thence 13 chains to road & in thence D 25 W 30 chains to Stake at beginning and also one other tract piece or parcel of land also situated in Greenville County containing four acres more or less adjoining lands of Haines Crotwell H. C. Mark and lands of the said H. G. Copel and together with all and singular the Right numbers. Writs, documents and appurtenances to the said premises belonging or in anywise incident or pertaining thereto. Have and to hold all and singular the Premises before mentioned unto the said Henry G. Copeland and his Heirs and assigns forever and I do hereby bind myself my Heirs, Executors and Administrators to warrant and defend all and singular the said premises unto the said Henry G. Copeland and his Heirs and assigns against me and my Heirs and all and every other person or persons lawfully claiming or to claim the same or any part thereof and I the said James A. Crotwell for myself and my Heirs, Executors and Administrators do covenant promise, grant and agree to and with the said Henry G. Copeland his Heirs and assigns by these Presents in manner and form following that is to say That I the said James A. Crotwell as legatee aforesaid am now at the time of the sealing and delivering of these presents lawfully and duly seized of and in the three tract of land and all and singular the Premises hereinbefore mentioned and do hereby grant and release a

parcel thereof with their and every of their appurtenances of a good, sure, perfect and absolute state of Inheritance in fee simple without any manner of Condition, Trust, Provisos, Powers of Revocation or Limitation or any use or uses or other restraint matter or thing what ever to alter, change, change defeat, or void the same and also that I the said James A. Crotwell as legatee aforesaid now have in my self good right full power and lawful and absolute authority to grant, release and confirm the said H. G. Copeland in conformity with a deed for titles executed to him by the late John M. Crotwell the three tracts of land aforesaid and all and singular other the premises hereinbefore mentioned and intended to be hereby granted and released and every part and parcel thereof with their and every of their appurtenances unto the said H. G. Copeland his Heirs and assigns forever as aforesaid And also that it shall and may be lawful to and for the said Henry G. Copeland his Heirs and assigns from time to time and at all times forever hereafter peaceably and quietly to enter into have, hold, occupy, possess and enjoy the said three tracts of land and all and singular other the premises hereinbefore mentioned and intended to be hereby granted and released and every part and parcel thereof with their and every of their appurtenances without any of the lawful Let, Suit, Trouble, Molestation, Execution or interruption of myself the said James A. Crotwell my Executors or Administrators or any other person or persons whatsoever! And that free and clear and truly and clearly and absolutely acquitted exonerated and discharged of and from all and all manner of former and other Gifts, Grants, Bargains, Sales, Leas, Wills, Inheritals, Devises, Judgments, Executions, Charges and Encumbrances whatsoever had made done committed or suffered by me the said James A. Crotwell or the late John M. Crotwell or any other person or persons whatsoever And Lastly That I the said James A. Crotwell and my Heirs and all and every other person or persons lawfully claiming or to claim my Estate, Right Title, Trust or Interest of in or to the said three tracts of land and all and singular other the Premises hereinbefore mentioned and intended to be hereby granted and released or any part or parcel thereof shall and will at all times hereafter at the reasonable request and proper costs and charges of the Law of the said Henry G. Copeland and his Heirs and assigns make do acknowledge and execute or cause and procure to be made done acknowledged and executed all and every such further and other lawful reasonable act and anything and things, conveyances and assurances in the said whatsoever for the further better and more benefit and
