To J Deed The State of South Carolina
Know all men by these Presents: That I Lewis W. Parker of Greenville City and County in the State aforesaid for and in consideration of the sum of Three Hundred and Seventy-five (\$375.00) Dollars to me in hand paid at and before the sealing of these presents by H. C. Dargan in the State aforesaid (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said H. C. Dargan all that piece parcel or lot of land lying and being in Greenville City, County and State aforesaid and being on Towns St. in said City the said lot containing thirty-one one-hundredths (31/100) of one acre more or less and having the following metes and bounds: beginning at a lane on Towns St between said lot and property of C. G. Leslie and running with said lane 206 feet to a stake at corner of said lane with another lane or alley, thence with said second lane S 15 1/2 W 67 feet to a stake, thence N 76 1/4 W 203 feet to a stake on Towns St, thence with said street N 10 1/2 E 67 feet to the beginning corner. Being lot # 6 of a plat made for me by J. M. Southern surveyor of two acres of land bought by me of Baptist Theological Seminary and Julia S. Wier, respectively, and being part of the lot to acre. Together with all and singular the Rights, Members, Hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining. To Have and to Hold, all and singular the said Premises before mentioned unto the said H. C. Dargan, his Heirs and Assigns forever. And I do further grant and convey to the said H. C. Dargan for the purpose of getting an entrance into the rear of the said lot, the use of and right of way of for himself, heirs and assigns, a certain lane of nine feet width between the said lot and property of C. G. Leslie and running with the line of said Leslie with a uniform width from Towns to Main Sts, also the right of way over and use of for above purpose of a certain lane at the rear of the said lot commencing at the lane first spoken of and running at the rear of all the lots fronted and now owned by me for a distance of 201 feet to the property of Mrs. Hannah and Lane having a width of 12 feet

said conveyance being for the purpose above given and being further upon the condition that the said H. C. Dargan shall pay his proportion to wit 1/6th of the expense necessary to keep said lanes in good condition and make thereon whatever improvements may be necessary. The Character of such improvements and the amount of expense therefor to be determined by a majority vote of the lot owners of the lots laid off by me on said land each owner to have one vote for each lot he owns and I do hereby bind myself and my Heirs, Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said H. C. Dargan his Heirs and assigns, against me and my Heirs and all other persons whatever lawfully claiming or to claim the same or any part thereof.
