

And Whereas said purchase was made by said party of the first part as a Trustee for and in behalf of the said parties of the second part and himself as the party of the first part do admit and declare: Now as aforesaid this written witnesseth That in consideration of the premises it is hereby agreed and declared by and between the said parties hereto that the said party of the first part his heirs and assigns doth and shall stand seized of the said land and premises with the appurtenances thereto conveyed by the deed herein before recited in trust for the said parties of the second part their heirs and assigns forever and will convey, lease or dispose of the same in such manner as they shall direct.

And the said party of the first part doth agree that until such time as the second parties may direct a conveyance thereof he will receive and collect the rents for such premises in trust for the said parties of the second part and will at their request make distribution thereof and of the proceeds of any sale or convey of such premises between himself and them in the same proportion in which the purchase money for these premises was paid And more particularly does the party of the first part agree that he will convey the said premises or any part thereof at the time and to such joint stock Company or Corporation as may be hereafter formed by the said parties of the second part himself or others whom he shall by so requested to do by the said parties of the second part.
