To All People to whom the presents shall come I Robert A. Maxwell do send greeting Know ye that I the said Robert A. Maxwell of the State and District aforesaid for and in consideration of the Love good will and affection which I have and do bear toward the ministers and members of the Methodist Episcopal Church among other denominations professing the Christian religion have given and granted and by these presents do fully give and grant unto James P. Southwell Philip Evans and members thereof their heirs and assigns the use of the meeting house and place of divine worship for the use of the

House lately built on my land near the way or road leading from Wilsons Ferry by John Richardsons to Greenville Court House with one acre of land in the Centre of which the meeting House stands so long as the said house shall be used or occupied by the said denomination of Professing Christians as a place of divine worship excepting only that the said house may be used as a school house when needed for that purpose or occasionally by ministers of other denominations but not thereby at any time to prevent or impede the performance of divine worship by the Ministers and members of the Methodist Episcopal Church according to the general usages of that Church And I do hereby bind myself my heirs executors and administrators unto the above named Trustees and their successors in office to warrant and defend the above mentioned privileges to the Ministers and members of the Methodist Episcopal Church so long as they shall see cause to occupy the said house as a place of divine worship
