river thence down the meandering of said river to a Sycam
Gum dead thence S 30 30 to the beginning corner contain

by lands of G W Gilcath by P Styles Margaret Collins
and others, and the said Robert L McLaughlin is to have
the boundary of the old Mill dam claim provided he
should ever want to put up machinery according to Mr
Abraham Collins word being the same tract of land conveyed

Hereditaments and Appurtenances to the said Premises
