Reedy River Manufacturing Co The State of South Carolina Known all men by these presents, That I S J Ashmore of Greenville County, in the State aforesaid in consideration of the sum of Two thousand four hundred and thirty Dollars to me in hand paid at and before the sealing of these presents by Reedy River Manufacturing Company, the receipt whereof is hereby acknowledged, have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said Reedy River Manufacturing Company its successors and assigns all that piece parcel and tract of land situate lying and being in Greenville County State of South Carolina, in Gantt Township, on both sides of Marrowbone Creek and on the west side of Reedy River, above Reedy River Factory containing one hundred and thirty five acres more or less, and having the following metes and bounds to wit; Beginning at a Post Oak 3+0m on the bank of Reedy River and running thence N 87° W 51.5° to a stake 3+0m in place of a pine gone, thence S 44° W 24.16° to a stone 3+0m thence N 70° E 9.00° to a stone 3+0m, thence S 26° E 18.5° to a stone 3+0m, thence N 57° E 4.90° to a stone 3+0m thence N 81° E 29.3° to a white oak 3+0m gone, thence N 35° E 19.5° to a stake 3+0m on River, thence up the meanders of the River 7.80 to the beginning adjoining lands of the said Reedy River Factory Mrs Lida J Morgan and others.
