To all to whom these Presents shall come: I D P Verner Master in and for the County aforesaid: Send Greeting: Whereas John Love Sr John Love Jr Bridget Love Nannie Love Hannah Love Lizzie Love and Kittie Love on or about the 19th day of February in the year of our Lord eighteen hundred and ninety two exhibited their complaint in the Court of Common Pleas for the County aforesaid against Maggie Love and Willie Love demanding judgment in relation to the real estate hereinafter mentioned and described and the cause being at issue came on to be heard on the second day of April 1892 and such proceedings were had therein as resulted in a decretal order of the said Court which was adjudged and heard that

D P Verner Master shall make and deliver to the purchaser or purchasers of the fifty acres of land described in the complaint a deed to all the undivided right title and interest in said lands belonging to Maggie Love and Willie Love who are minors giving to said purchaser a good and sufficient title thereto said deed to be made not until after all the heirs at law capable shall have executed a deed conveying their interest in said and shown said conveyance to the master the purchase price of said fifty acres to be one hundred and fifty dollars and the said heirs having made said conveyance and shown the same to the master as required by the terms of said decree & same having been conveyed to J M Langley by the heirs capable. O. thence S 82 W 5.50 to a branch, thence up and with the meanderings of said branch to the head thereof, thence S 5 W 15.00 to a dog wood near a road, thence with said road to the beginning corner containing fifty acres more or less and bounded by lands of J C Allen Wm Rudwell and others being the same land conveyed to Elizabeth O Love by Pinkney Burns.
