whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these presents, DO GRANT, bargain, sell and release unto the said J L Donaldson all that lot of land situate in the county and State aforesaid near the city of Greenville a short distance north of the county road known in a division of a tract formerly owned by P D Green, deceased as lot No 10 containing six and one-half acres more or less and having the following metes and bounds to wit Beginning at a stake on a twenty foot road running thence S 27 E 15 75 to a stake three rods E 10 34 40 to a stake, thence N 22 W 15 20 to a stake thence S 62 W 15 30 to the beginning except in so far as said case may be in question of the 28<sup>th</sup> November 1891.
