Roberts his heirs and assigns.

All of my right, title interest and estate, within legal and equitable, of in or to all and singular, All of that tract of land, situate lying and being in the State and County aforesaid and being the same lands conveyed to the said J. H. Roberts by deeds from Mary C. Kendrick, Nancy A. Russell, Martha A. Allen, and Benjamin M. Beardsley and being part of the tract of land devised to James P.
