in the State aforesaid for and in consideration of the sum of Two hundred and Sixty Dollars, to see in hand paid at and before the sealing of these Presents, by A C Davis also of said County and City of Greenville (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these Presents, DO GRANT, bargain, sell and release unto the said A C Davis all that certain piece parcel

or lot of land situate, lying and being, in Ward 4 in the City of Greenville County of Greenville and State aforesaid, on the West side of Wood street, and having the following metes and bounds course and distances to wit: Beginning at a stake on the corner of said St and an alley, thence with the said St in a southerly direction 73 1/2 feet to stake corner of one of Griffith's lot, thence with the said Griffith's line 40 feet to stake corner of Satterfield's lot, thence with said Satterfield's line 71 feet to stake on alley, thence along and with said Alley 37 1/2 feet to the beginning corner, containing 280 1/4 Sq feet, more or less.
