in the State aforesaid for and in Consideration of the sum of
Five dollars to us in hand paid at and before the sealing of
these presents, by Mary P. Cleveland and in Consideration of
her Conveyance to us of her interest in the estate of James
Harry Cleveland, deceased, by deed of the same date with these
presents in the State aforesaid, (the receipt whereof is hereby acknow-
ledged,) have granted, bargained, sold and released unto these
Presents do grant, bargain, sell and release unto the said Mary
P. Cleveland (all our right, title, interest and estate in all the real
Estate of which the said James Harry Cleveland died seized and
possessed, saving and excepting so much thereof as has been conveyed
to me by said parties as my share of his estate.)

The following is a description of the real estate hereby intended

on Cleveland Avenue 34. Thence S 10 E. 12.24 to stone 34. Corner of
Mrs. E. M. Cleveland's four acre lot. Thence N 80 E. 6.30 to stone on
Cleveland Avenue. Thence along Cleveland Avenue S 10 E. 5.50 to
iron fence in bend of said Avenue. Thence S 21½ W. 21.07 to
stone at J. G. Ford's corner. Thence S 69 E. 5.50 to stone 34. Thence S 21½
W. 17.80 to iron fence 34 on Ford street. Thence down said street,
(5) 50½ E. 4.58 to stone. Thence N 59¾ E. 5.58 to R. 0. stamp 34. Thence
S 46 E. 26.10 to R. 0. 34 on road near McWay's bridge. Thence along said
road to stone in center of said bridge over North Saluda River. Thence
up said river with its meanderings to gum stamp, corner of
Marietta Baptist Church lot. Thence N. 80. W. 5.00 to stone 34.
Thence N. 50 W. 5.50 to fence 34. Thence N. 35 E. 3.00 stone 34 on R.R. & W.
R.R. Thence S. 64 E. 9.50 to stone on river. Thence up said river to begin-
ning. (Less one acre for Rail Road.) Also the tract of land on West
side of Cleveland Avenue. Beginning on a stone 34 on Broad Street.
Thence S. 88 E. 19.50 to stone 34 on Cleveland Avenue. Thence up said Avenue
N 21½ E. 4.00 to stone 34. Thence N. 68½ W. 6.50 to st. 34. Thence N 31½
E. 3.50 to st 34. Thence S. 68½ E. 6.50 to st. 34 on Cleveland Avenue. Thence
