and before the sealing of these presents by J D Guest, aforesaid (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J D Guest, all our right, title and interest of an and to all those certain five pieces parcels or tracts of land situate lying and being in the State and County aforesaid, on the wuluf of and on the south side of North Saluda River, our said interest being a one third interest each as devised under the will of our father William M Guest, to wit: Lots Nos 3, 4, 5 and 6, containing in the aggregate twenty two and one half acres more or less, on plat of same being included in the following metes and bounds: Beginning at a stake on a branch and in a Gully, thence with said gully S 88 10 1/2 W 7 3/4 to a stake in the Gap Creek Road, thence West 16, 30 to a stone x, thence N 24 1/2 W 7 7/8 to a stone x on Beatties line, thence S 65 2 1/2 W 6, 25 to a stone x on the Jawbone Hill, thence S 10 3/4 E 6, 34 to a stone x, thence S 3 2 E 8, 00 to a stone x, thence N 7 7/8 E 16, 35 to a stone on the road aforesaid, thence with said road 6, 74 to a stone x, thence N 63 E 5, 07 to a Sycamore x, on branch, thence down branch to the beginning stake, and lot No 10, containing twenty five and one half acres, more or less, beginning at a stake on, on north Saluda River, thence S 26 1/4 E 23, 30 to a stone x, thence N 8 1/2 E 14 20 to a stake x in a road, thence N 10 1/2 W 16 25 to a stone x, thence N 3 0 1/2 W 10, 00 to a Birch stump x, on said river, at a ditch, thence down the meanders of said river to the beginning.
