KNOW ALL MEN BY THESE PRESENTS, That

I, John Gornall, of Greenville County in the State aforesaid... of Twenty Dollars to in consideration of the sum and before the sealing of these presents by The County of Greenville (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said County of Greenville, its successors and assigns...

All that piece parcel, or strip of land situate, lying and being in the County and State aforesaid, in Chesham Township, being a part of the re-location of a portion of the old State Road in said Township near what is known as the "big cave" on said Road. This piece or strip of land being a continuation of the re-location of said State Road near said cave, said re-location of said Road running through the borders of Mrs. Mary R. Lynn and my self, and being where said new Road enters my land from the land of said Mrs. Lynn and running through my land for a distance of about 219 yards to the said old State road near the residence of Miss Emily Gilreath. Said strip or parcel of land being on the North side of said State Road, and 9 feet in width the entire distance.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said County of Greenville, its successors and assigns, Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said County of Greenville, its successors and assigns, against me and my Heirs, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
