for and in consideration of the sum of five dollars and the further consideration that the said Belton Wood is to care for and support me for and during my natural life and the further consideration of love and affection for my son, Belton Wood, to me in hand paid at and before the sealing of these presents, by Belton Wood of the said State and County (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Belton Wood, all that certain piece parcel or lot of land, situate lying and being in the County of Greenville, and State of South Carolina near the incorporate limits of the City of Greenville, adjoining lot of Sam Williams, and having the following metes and bounds, to wit: Beginning at a stake on Williams street, corner of the said Sam Williams lot, and running thence with the said Williams street N. 77.1/2 W., to stake on corner of Williams and Brockman streets thence along the said Brockman street S. 12.1/2 W. 3.18 chains to stake corner of T. C. Gower's Lot thence with the last named lot S. 77.1/2 E. to stake corner of the said Sam Williams' Lot, thence with the said Sam Williams' line to the beginning corner.

TOGETHER with all and singular the Rights, Members, Hereditments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said Belton Wood his Heirs and Assigns forever.

And I do hereby bind myself and my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said Belton Wood, his

Heirs and Assigns, against myself and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
