(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John Green and Annie Green, Their two third interest in the following described land All that lot, piece or parcel of land lying, being and situate in the City of Greenville, County of Greenville and State aforesaid and having the following meets and bounds as follows, Beginning at a post on John street being the west corner of the Reese lot and running thence with Johns street N. 50 1/2 W. 253 feet to an iron stake near branch thence N. 52 E. 115 feet to a point marked with an iron stake thence S. 50 1/2 E. 229 feet to a stake on line of said Reese lot thence with said Reese line S. 39 1/2 W. 115 feet to beginning point on Johns street The same being a part of lot of land purchased by the said Nettie L. Yarnon on the 24th day of March A. D. 1900 and deed recorded in office of Register of Meese Conveyance for Greenville County in Book T. V. page, 691. This being the same tract of land conveyed to John Green, Jarob Hanna and Amon Abraham by L. L. Barr on the 14th day of October A. D. 1904 and recorded in Volume N. N. N. page 158.

Heirs and Assigns, against us and our Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
