KNOW ALL MEN BY THESE PRESENTS, That I, Julia Ann, T.E. Bentley of Union County, in said State, have constituted, made and appointed, and by these presents do constitute make and appoint J. Fincher Harris, formerly of said County, my true and lawful Attorney for me and in my name and stead, and to my use, to ask, demand, sue for, levy recover and receive all such sum and sums of money, debts, rents, goods, wares, dues, accounts and other demands, whatsoever, which are or shall be due, owing or payable to me or detained from me in any manner or ways or means whatsoever; and to take full charge of & control over & concerning all of my lots or parcels of land situated within & without the limits of the City of Greenville, South Carolina, but within the limits of the County of Greenville in said State and to sell each of said lots or parcels as he may deem proper or necessary & make proper deeds to the same, said to purchase such other lots & parcels as he may deem proper & necessary and to sell same or any of them if he sees proper and to mortgage same or any of them if he deems it proper & to execute proper mortgages & notes is bound for such debts & may he thereto controlled.

Giving and granting unto my said Attorney by these presents full and whole power, strength and authority in and about the premises he to have, use and take all lawful ways and means in my name for the recovery thereof; and upon the receipt of any such debts, dues or sums of money aforesaid, acquittance or other sufficient discharge, for me and in my name to make, seal and deliver; and generally all and every other act and acts,, thing and things, device and devices in law whatsoever, needful and necessary to be done in and about the premises for me and in my name to do, execute and perform, as fully, largely and amply, to all intents and purposes as I might or could do, if I were personally present. Or if the matter required more special authority, than is herein given, and Attorneys one or more under him for the purpose aforesaid, to make and constitute and again at pleasure to revoke ratify, allowing and holding for firm and effectual all and whatsoever my said Attorney, shall lawfully do in and about the premises, by virtue hereof.
