NOW, Therefore, Know all Men by these Presents, that I, J. W. GRAY, Master in and for the County of Greenville, aforesaid, in consideration of the performance of the conditions aforesaid, and the payment of Eighteen thousand six hundred fifty (\$18,650.) Dollars, by the said O. Mills Goodlett

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said O. Mills Goodlett, All that piece or lot of land in the City of Greenville, State and

County aforesaid, containing one-tenth of an acre, more or less, being the same land conveyed to M.W. Goodlett by W.A. Barton, said conveyance recorded in R.M.C. office in Book "GGG" page 776. For description by metes and bounds see said deed.

One undivided one-half interest in all that piece, parcel and lot of land in the City of Greenville State of South Carolina, being the same conveyed by Maybury Land Company to M.H. Goodlett on October 10th, 1908, recorded in R.M.C. office book "XXX" page 65, and held by him in trust for the heirs of M.W. Goodlett. For description by metes and bounds see said deed. A l s o, the stock of goods on hand at the death of M.W. Goodlett as of date September 1st., 1909.

To HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said O. Mills Goodlett, his

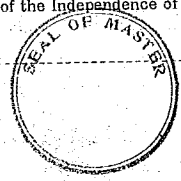
heirs and assigns forever.
