share of Jane Thompson being an undivided one-half interest and that of each of the other grantees an undivided one eighth interest, All that certain tract of land situate in Paris Mountain Township, County and State aforesaid, known as Tract No. 5 of the Estate of Gabriel Thompson, deceased, made by W.A. Hester, Surveyor on the 21st, day of November 1910 containing fifty one and one-half (51-1/2) acres more or less, and having the following metes and bounds, to wit: Beginning at a pine on branch, et edge of Saluda Dam and running; thence S. 64-1/2 E. 4.00 to stone NM; thence N. 33-1/2 E. 29.50 to Pine XX 3NM; thence N. 40-3/4 W. 21.00 to stone on branch; thence down said branch as the line 43.00 to pine at edge of Saluda Dam, the beginning corner.

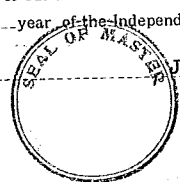
