the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said Minnie A. Stokes, all that certain parcel or tract of land situate in Dunklin

Township, County and State aforesaid, containing thirty-one and a half (31-1/2) acres, known as tract No. 5 in plat of survey of lands of J.W.
