Thompson, Two hundred & fifty acres of land in the County of Greenville, State of South Carolina, situated on both sides of Morgans Creek; Beginning at a Poplar, n. 43 co to a red-oak N. 25 W. 35. to Robert Good and Jonas Dawson's to a Ches. oak 3X pouch & corner N. 62 W. 30.00 to a red-oak 0 ost West 35.00 to a spanish-oak at the head of Medded branch thence taking the demanders of said branch C. cross said Morgans Creek to the old line to a white-oak; thence S.00 to red-oak; thence S. 30.00 C 03 000 to Abston Thompson line to a stake E. 23.5 to a red-oak; thence N. 19 to line of statson on a Poplar bounded by lands of Bird Evans, Holland Center, Harriet Ross, Mathew Ballew and Goshen Ross containing two hundred and fifty acres more or less, and known as the Kytte land the said land having been willed to David H. Gollightly & Mary Jane Gollightly, Mathew Brisack, and heirs of Melville Gollightly, deed,

And I do hereby bind Myself & Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said J.D. Humphreys & A.L. Thompson, Heirs and Assigns, against me and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
