Stone all those certain

lots in and near the City of Greenville, County of Greenville, State of south Carolina being in the Sections and having the numbers hereinafter mentioned, the same being shown on a plat of Stone Land Company made by J.E.Sirrine on May 21st 1909 and recorded in the office of the Register of Mesne Conveyance for Greenville County in Plat Book A-page-- 337-345

Section A-- Lots number two, nine, twenty one.

Section B-- Lots numbers nine, twenty one, twenty eight, forty two, forty nine, fifty two.

Section C-- Lots number twenty eight, twenty nine, thirty, thirty three,

Section D-- Lot number seven.

Section E-- Lot number thirteen.

Section F-- Lots number thirteen, sixteen, twenty nine, thirty four.

Section G-- Lots number six, fifteen, twenty two.

Section I-- Lots number three, six, nine, fourteen, fifteen, sixteen, twenty, twenty five, twenty seven, five.

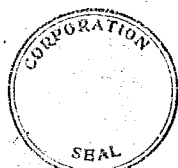
Tract No. One- Beginning at an iron pin in the Chick Spring road one hundred ninety one feet and four inches north of the iron bridge over Richland creek, and running thence four hundred sixty four feet to an iron pin in a ditch at corner of T.Q.Donaldson's land as established by L.P.Slat-tery and W.A.Hudson May 1909; thence S.40.50 E. fourteen hundred thirty seven feet to a stone cor-ner in line of Parker and Donaldson; thence in a northwesterly direction to a point in the Chick Springs road; thence N.S.11 E. two hundred eleven feet and nine inches to a point in said road; thence N.24.49 W. one hundred seventy two feet and three inches to the beginning corner, containing four-teen and eight tenths acres more or less.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining To have and to hold all and singular the premises before mentioned unto the grantee hereinabove named, and her heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
