limits of the City of Greenville, and near Brandon Mills, known as No. 4 of Honour Row, measuring on Pendleton Road, starting from Lot No. 3 running West Sixty (60) feet to lot No. 5; thence South to Southern railway right-of-way two hundred (200) feet more or less; thence East back to Lot No. 3 sixty feet, more or less; thence back North two hundred (200) feet to Pendleton Road.

This property cannot be sold to negroes.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Charles Seignious Honour, his heirs and assigns, forever.

AND I do hereby bind myself -- heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Charles Seignious Honour, ---

heirs and assigns, against me and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
